HEARTS FOR SENIORS (HFS) IS A COMPANION CARE PROGRAM FOR SOCIALLY ISOLATED SENIORS HERE IN OUR COMMUNITY. HFS IS TO SUPPORT SENIORS WITH THEIR EVERYDAY TASKS, ALL WHILE BUILDING AND FOSTERING RELATIONSHIPS.
